Why has God called you here?

Obadiah "The poverty of privilege & the privilege of poverty"- Reconcilers, stewards, gentle footstep on the earth. My struggle is a community struggle.

JPJ- The divide between the congregation and the neighborhood- Pastor vs. Monk? Finding God in the neighborhood. "I don't want to do silent worship, I want to go paint someone's house." "It's worth it"

Greg- "Your hat hath ribbons, our hats have none"- William Penn "We are a silly people if we are worried about what people are wearing and not their spirits" I wanted to be in community with people and I didn't want to be in community with people who were perfect. I need to be here

Louis- Needed to be a part of something larger. Music as a path to ecumenical ministry and

relationships. Accountability, siblings in common. I don't have to hide anything, be myself and have others be authentic. I want to cast my lot here because the community has cast their lot with me.

Richard- Instead of cops and robbers, I played church. Helping others heal from the inside out. I belong here, you belong here and we're really in this together.

Betty Lou- I don't always know the why of God, but I know it's not about me. Jonah stories. SD-"You're Franciscan whether you profess or not" "Pre-guilt? Pre-confession!"

Do you feel free to leave us or will you always remain?

To Obadiah- so far away! How to connect and sustain the call?

To Louis- what can you bring from your community life and from experimental communities to enrich our lives?

Candidates were dismissed for Professed session at 10:14

Ballots were distributed to the voting members.

The ballots were reviewed.

The vote was unanimous to receive all 6 candidates for profession. They have now been admitted to voting privileges for the remainder of the meeting.

Session 3- OEF Chapter Called to Order at 10:45 AM

Opened with the singing of "Spirit of the Living God"

Michael Vosler introduces the 3 sessions:

- 1. Review of process
- 2. The discernment process
- 3. Where do we go from here?

Chapter 2014- the three options (with collaboration as a core value)

- 1. Existing Statutes
- 2. Statutes draft with a Co-Minister model
- 3. Statutes draft with a Council model

Three major changes:

- 1. Trust in the Spirit to guide our process.
- 2. From Minister General to a Council leadership
- 3. Collaboration and mutuality in all of the service offices

Carlo Gendron sets a ground rule: let us make business into prayer.

Michael Vosler examines the wide variety of feedback from members while noting that no amendments or revisions were included in the proposed draft.

Carlo Gendron leads a review of the responsibilities of the Council (Article V.) Four Highlights:

- 1. Collaborate/Delegate as needed
- 2. Deep listening/prayerful discernment
- 3. Spiritual Development
- 4. Encouraging all members to care for one another

Open Question & Answer:

- 1. Leaders vs. guides?
- 2. Potential risks- lack of clarity leading to ineffective membership?
- 3. Overscheduling/regulating the council? How to understand who does what.
- 4. A timeline for the Council to share how they are sharing responsibilities.
- 5. Trusting in the prayerful discernment vs. a win-lose model

Shoshanah closes session in prayer.

Session 4- OEF Chapter Called to Order at 4:15 PM

Carlo Gendron introduced the session with some highlights from the introductory letter, highlighting the core values that the team followed in preparing the draft.

Background information

Small groups were formed to tackle the following question:

- 1. When you are personally seeking God's will, how do you discern God's voice from your own?
- 2. How does my participation change in discerning God's will when I am in a group?
- 3. How are we to discern together when the Spirit has spoken?

Presentation of the foreword and afterword

Session was continued to 6:00 PM

Group sharing

Questions:

- 1. Can we say that we are prepared to use prayerful discernment for our community business?
- 2. Can we say that we are willing to experiment for at least a year with a council instead of an MG and a Chaplain?

Session 5- OEF Chapter

Called to order at 4:15 PM

Michael Vosler opens with a reading from Richard Rohr, OFM about the power of the indwelling Spirit.

Members were invited to share their experience of yesterdays sessions.

As one Sister described it:

"There was abundant sharing, most often with simply a word or phrase. Some of those included: truth, courage, unity, community, communion, peace, love, patient trust, deep listening, humility, softness, openness, willing to risk, receptive, awake, shift, openness to the Mystery, presence of the Holy Spirit was palpable, surrender."

Shoshanah expressed a sense of unity on the use of prayerful discernment for business and requested input, questions feedback from those absent vesterday.

There was no additional feedback given, unity was affirmed

Shoshanah expressed a sense of unity on the willingness to experiment with the council model for a period of time to be determined.

There were a few brief comments, but no decision to block or stand in the way. Unity was affirmed.

Juniper began a discussion of the Council Selection process in the proposed Statutes

There was a sense of unity that we have affirmed 1. prayerful discernment, 2. The council, 3. a selection process at the next chapter.

We closed out session with a prayer from Michael Vosler and with music from Br. Al Mascia, OFM

Session 6- OEF Chapter

Shoshanah opens in prayer

Michael Vosler offers words of welcome and recognition to Petra.

Shoshanah announced the completion of her term on the Joint Commission on Franciscan Unity and the appointment of Br. Louis Canter and Br. Elijah LeFevre. She gave thanks for the work of Br. Coyote & Sr. Katie Cook and announced the appointment of Br. Romero Williams and Sr. Magdalena Stebbing as additional JPIC animators.

An opportunity for feedback on the servant reports was given.

Some questions were entertained about the financial report, including encouragement to all members to make a a regular habit of financial giving to support the work of the Order.

The idea was proposed that our financial stewardship covenant could be enhanced by intentional work of one or more professed purposefully engaging the membership and the cloud of witnesses who are connected to the community.

Community affirms Michael Vosler and Coyote as the Generosity Team.

JPIC work was affirmed as a valuable resource to share with the larger world.

Additional charges to the Team:

Encouraging regional gatherings to practice an act of prayerful discernment

Community affirmed the new team and their ongoing work.

Requests for the team:

- 1. Prompting for pre-chapter preparation
- 2. Work on process to prepare the community for a Council Selection process
- 3. In preparing for selection, consideration should be given to balance of continuity, stability and

durability. The team can communicate with the members to help define some of these needs.

Invitation to prayer

Members should be prepared to respond in full to the next inquiry about Chapter 2017 date.
